



Amplified Sound Permit – Notification Affidavit

Upon notice of tentative approval of a permit for which amplified sound equipment is to be operated, the applicant for a permit shall be responsible for mailing or otherwise delivering to the occupants of each property within a 1,000-foot radius of the facility for which the permit has been granted, as shown on the tax maps of the county, a notice stating the date and hours of the event. The notice shall be delivered at least 72 hours in advance of the event. The permit shall not be actually granted and issued until the applicant submits an affidavit to the town that such notices have actually been mailed or otherwise delivered.
